Dear Mr. Yarter:

This office is in receipt of your response to the above-captioned complaint. In your response you state that you attempted to file Concerned Officers Preserving Safety's ("COPS") Contributions and Expenses Report timely but could not find any information on our website concerning due dates for the time the reports were due. You have requested a waiver of the \$1, 375.00 penalty assessed to COPS pursuant to NRS 294A.420.

In your request for a waiver you did not provide a reason for which a waiver may be granted pursuant to Nevada Administrative Code ("NAC") 294A.097. Therefore, your request for a waiver is denied.

Please submit payment in the amount of \$1,375.00 to this office no later than Friday, May 13, 2011. If you are unable to make the payment in full at this time, please contact this office to set up payment arrangements. This office sent you correspondence on April 19, 2011, regarding the above-captioned complaint. The complaint alleges that Citizens for Responsible Leadership and Ethics ("CRLE") violated sections 294A.140 and 294A.210 of the Nevada Revised Statutes ("NRS"). Specifically, it has been alleged that CRLE sent out flyers opposing Richard Cherchio, candidate for city council, and did not report the expenditures as required by NRS 294A.210. In our original correspondence, this office provided you until May 2, 2011, to respond. As of the above date, no response has been received.


